7. **The purpose of the discipline:**
 - practical: formation of communicative speech competencies and the ability to apply their knowledge of English for foreign language communication in higher education. And also apply their knowledge when listening, speaking, reading and writing.
 - educational: formation of higher education students' understanding of the essence of language phenomena; comparison of foreign language phenomena with native language; involvement in the dialogue of cultures; mastering knowledge about the culture, history, realities of a foreign country; ability to work with professional information resources.
 - developing: development of skills to apply the acquired knowledge and skills in a certain (professional) speech situation on the basis of problem-solving activities; speech abilities; intellectual and cognitive abilities; readiness to participate in communication with native speakers; readiness for self-education at advanced levels of foreign language proficiency.
 - educational: education of applicants for higher education culture of communication, which is accepted in the modern world; value orientations, feelings and emotions; positive attitude to a foreign language, culture of the people who speak this language.
 - social: the ability to communicate and make a significant contribution to the ever-changing international environment.
 - socio-cultural: to achieve a broad understanding of important and diverse international socio-cultural issues.
8. **Course format:** conducting practical classes for a better understanding of topics.

- 15.** Evaluation system and requirements: evaluation is carried out on a 100-point scale: current control - 1.8 -3 points, content modular control -1.8 -3 points, final modular control - 24-40 points.

During the practical classes the current control (mastering the topic) and control of content modules (CCM) is carried out.

Current and intermediate control is performed in the following forms: frontal and individual survey, computer tests, individual written tasks, presentation, written tests, control of practical skills, solving situational problems; group discussion, test reading and translation.

The final control of mastering is carried out at the end of the study of the discipline in the final control classes. It is carried out by writing the final modular work, which consists of lexical and grammatical tests (20 points), tasks for comprehension of the text (10 points) and a conversational topic (10 points).
